Existing law requires the State Department of Education to develop guidelines for the use of telehealth technology in public schools to provide mental health and behavioral health services to pupils on school campuses, as provided. This bill would require, on or before November 1, 2024, county offices of education, in consultation with the department and other relevant state and local agencies, to coordinate agreements between school districts and charter schools within the county to develop a system for rapidly deploying qualified mental health professionals and other key school personnel employed by individual school districts and charter schools throughout the county to areas of the county that experienced a natural disaster or other traumatic event, as provided.

The bill would also require the review to identify barriers to, and opportunities for, access to mobile and fixed broadband internet service infrastructure by low-income tribal, urban, and rural customers, and underserved communities. The bill would further require the review to provide recommendations on how to accelerate deployment of broadband access points to serve tribes, low-income customers, and disadvantaged or underserved communities.

Notes:

The bill amends existing Medicaid limitations on FQHC/RHC ability to establish a new patient relationship via certain telehealth modalities. Language states that an FQHC/RHC shall not be precluded from establishing a new patient relationship via audio-only and clarifies limits around allowing for asynchronous patient establishment language.

The bill also adds section related to licensed enrolled clinics providing care via telehealth, listing certain restrictions on the Department of Health Care Services, including that the Department is prohibited from adopting telehealth reimbursement policies that are more stringent than those imposed on equivalent in-person services.

The bill also amends the existing definition of synchronous telehealth to explicitly add audio-only, applies existing private payer parity requirements to counties, and allows enrollment and recertification via virtual modalities including telephone for Medi-Cal programs.

The bill requires the department to complete an evaluation on the benefits of telehealth in Medi-Cal by July 2025 as well.

This bill would include associate professional clinical counselor trainees in the definition of health care provider for purposes of the provisions authorizing the delivery of telehealth. The bill would authorize associate clinical social workers, associate professional clinical counselors, and clinical counselor trainees to provide services via telehealth within their scope of practice. The bill would require an applicant for licensure as a marriage and family therapist, a licensed educational psychologist, a licensed clinical social worker, or a licensed professional clinical counselor to show, as part of their application, that they have completed 3 hours of training of coursework in the provision of mental health services via telehealth, including law and ethics relating to telehealth. The bill would also require completion of that training requirement as a one-time requirement for licensees before the time of their first renewal after July 1, 2023, and for applicants for reactivation or reinstatement to an active license on or after July 1, 2023.

This bill would define "face-to-face contact" specific to "one hour of direct supervisor contact" for behavioral health licensee applicants to mean in-person contact, contact via 2-way, real-time videoconferencing, or some combination of these. The bill would make the supervisor responsible for ensuring compliance with federal and state laws relating to confidentiality of patient health information. The bill would require a supervisor within 60 days of the commencement of supervision to conduct a meeting with the supervisee during which the supervisor is required to assess the appropriateness of allowing the supervisee to receive supervision via 2-way, real-time videoconferencing.

This bill would provide that face-to-face contact is not required when covered health care services are provided by video synchronous interaction, audio-only synchronous interaction, remote patient monitoring, or other permissible virtual communication modalities, when those services and settings meet certain criteria. The bill would require a provider furnishing services through video synchronous interaction or audio-only synchronous interaction to also offer those services through in-person face-to-face contact or arrange for a referral to in-person care, except as specified. The bill would authorize a provider to establish a new patient relationship with a Medi-Cal beneficiary through video synchronous interaction, as specified, and would prohibit a provider from doing so through the other modalities, except as specified. The bill would set forth other requirements on the State Department of Health Care Services or a Medi-Cal provider relating to the use of those telehealth modalities, including requirements concerning fee schedules and minimum reimbursement limits, services in border communities, as defined, consent standards, privacy and security compliance, informational notices, and a research and evaluation plan.

This bill would expand "visit" to include an encounter between an FQHC or RHC patient and any of specified health care professionals using video synchronous interaction, audio-only synchronous interaction, or asynchronous store and forward modality when the applicable standard of care and other conditions are met. The bill would set forth other requirements on an FQHC or RHC relating to the use of those telehealth modalities, including requirements concerning reimbursement rates, consent standards, privacy and security compliance, the establishment of new patient relationships, and in-person services or referrals.

This bill would authorize the department to allow a Medi-Cal managed care plan to use clinically appropriate video synchronous interaction as a means of demonstrating compliance with the time or distance standards, and as part of an alternative access standard request.

This bill would expand reimbursement for medically necessary Drug Medi-Cal services and to other authorized individuals, as specified, when those services are delivered through video synchronous interaction or audio-only synchronous interaction. The bill would similarly set forth certain requirements relating to privacy and security compliance and the establishment of new patient relationships through telehealth modalities. The bill would require the department to adopt regulations by July 1, 2024, to implement these provisions.

This bill would require the department to establish a program for the operation and regulation of mobile narcotic treatment programs. The bill would require those programs to meet specified requirements, including that they operate under the license of a primary narcotic treatment program and receive approval from the department before operating a mobile narcotic treatment program.
