

INTERIM FINAL RULE APRIL 1, 2020

The Center for Medicare and Medicaid Service (CMS) submitted an <u>interim final rule</u> that included changes to telehealth policy in Medicare. Some of these changes have also been explained in CMS guidances recently issued, but not all items were covered by the CMS released materials.

Modality	Allowance of smart phone, but still must have audio/visual - We are adding the following language at § 410.78(a)(3)(i): "Exception. For the duration of the public health emergency as defined in § 400.200 of this chapter, Interactive telecommunications system means multimedia communications equipment that includes, at a minimum, audio and video equipment permitting two-way, real-time interactive communication between the patient and distant site physician or practitioner." Direct Supervision Requirements	Temporarily alter definition of direct supervision in §410.32(b)(3)(ii) to "state that the necessary presence of the physician for direct supervision includes virtual presence through audio/video real-time communications technology." Similar changes also for §410.28(e)(1) for certain hospital and CAH diagnostic and therapeutic services & §410.27(a)(1)(iv)(D), pulmonary rehabilitation, cardiac rehabilitation and intensive cardiac rehabilitation. Homebound definition	Includes those self-quarantining with COVID-19 diagnosis or those who would be at greater risk of exposure.	Pages 61-62
